- The community needs to be consulted and then the bylaws must be presented to and approved by the provincial citizens council
- Once the bylaws are approved, we hold a special resolution to hold an election, after this occurs, we have 21 days to call an election.
- Law group will support us all along the way, come to our meetings
- The resources for the district don't come until the captain is elected, there is not a good sense of how much budget will be, support for admin, staff, building costs, etc.
- Some of the documents Anna Marie has completed for review/developed in consultation with the executive are: Financial delegation, skills matrix, volunteer policy, board member role designations, still need to develop HR policies, fair business practices that are contextualized to the Metis local.
- We need to consider how to incorporate engagement with expanded communities as the district boundaries are larger than the local; need ideas on how to expand the council to integrate and still respect geographic communities
- Model bylaws that we can tweak are on the MNA website, there will be a meeting with the citizen's council that are set in Feb, so we should try to build the bylaws asap
- There are 11/22 districts that are already on the process to move to interim district
- Action: We will send out the bylaws. Rev will send out updated model bylaws in the newsletter. Encouraged membership to read the bylaws on the MNA website. If in blue the bylaw can be changed, anything in a black box is an explainer.
- Next local meeting: plan to review bylaws-January 24th
- Invited members to provide input of draft bylaws
- Role of citizen's council: There are 3 citizen's representatives; 1 representative for women; 1 for youth and one for our district
- Captain=mayor; Citizen=MLA/MP
- We will be asking the 3 representatives to advocate and act on our behalf and to represent us
- We will be reaching out to the women, youth and citizen rep to invite them all to our meetings
